



Agency Agreement

In consideration of MOORE CREATIVE TALENT, INC, hereinafter referred to as the AGENCY, efforts in obtaining employment for me – hereinafter referred to as TALENT – as a Model, Theatrical Performer, Voice Actor, or other occupation, as may fall within the intent of a Minnesota Theatrical License, in the field of advertising, art, entertainment, radio, television, theater, promotional endeavors, and others:

I \_\_\_\_\_ hereby agree to pay the AGENCY 20% (10% for Film, Broadcast and Voice over) for all bookings from all TALENT FEES received by me as the result of employment obtained by, through, and as a result of the efforts of this AGENCY; or by, through, or as a result of information obtained as a result of contact with the AGENCY, I agree to pay the AGENCY all TALENT FEES, as referenced above, received by me from any additional employment with Employer’s with whom I first received work through the AGENCY. Such additional fees shall be based upon the aforementioned fees. I agree to refer any Employer’s making direct offers of employment to me to the AGENCY. Provided that this shall not be construed as prohibiting my right of private contract with any Employer contacted by me.

I agree that all TALENT FEES earned by me shall be made payable, and paid directly to the AGENCY. The AGENCY is hereby authorized to deduct its percentage before transmitting payment to me. Should payment be forwarded to me directly by the Employer, I agree to reimburse the AGENCY the agreed percentages stated above.

It is further understood and agreed:

- A) This is effective from: \_\_\_\_/\_\_\_\_/\_\_\_\_
- B) That any work performed by me will be as independent contractor, not as an employee, and I am responsible for reporting taxes, social security, workmen’s compensation, etc.
- C) That the 20% & 10% FEES herein mentioned above are the only missions and/or other charge or charges payable to the AGENCY not including the AGENCY no risk web FEE of \$50.
- D) The AGENCY shall pay the FEES to the TALENT as soon as practicable, after receipt of payment from employer. I understand that if the AGENCY does not receive payment from the employer, the TALENT cannot be compensated for their work.
- E) That confirmation of a booking means the TALENT will represent the AGENCY just as the AGENCY represents the TALENT, meaning on time, prepared, acceptable presence at said booking. If TALENT fails to respond or attend a booking/job TALENT will be removed from the AGENCY website and all affiliates with AGENCY. This Agreement will be VOID.
- F) There is a 45-day waiting period before the AGENCY will reissue a lost check to the TALENT. A \$28 stop payment fee will be charged.
- G) This Agreement is continuous and will remain in full force and effect until terminated in writing by either the AGENCY or the TALENT.
- H) That this Agreement constitutes the entire Agreement between the AGENCY and the TALENT and no statement, promise or inducement made, which is not contained herein, shall not be binding or valid. This Agreement may not be expanded, modified, altered or assigned except in writing and signed by both the AGENCY and the TALENT.
- I) That whenever this Agreement conflicts with SAG-AFTRA regulations or rules, it is to comply with said rules or regulations.

I have read and understand this Agreement, and do hereby acknowledge the receipt of a copy of the same.
